Clinical Commissioning Groups (CCGs) are the centrepiece of the new, clinically-led commissioning system introduced by the Health and Social Care Act 2012. CCGs will be responsible for:

- understanding and planning the local population's healthcare needs
- commissioning healthcare services for their population
- building strong local relationships, including with local authorities, patients and the public.

This clinically-led approach brings potentially large benefits in meeting the healthcare needs of the locality. In order to achieve those benefits, CCGs will need to operate within a legal and contractual framework and public procurement is a key part of this.



Failure by a public body to comply with the regulations on procurement can, and increasingly does, expose that public body to challenge, leading to delay, increased costs, awards of damages, the setting aside of contracts and even the imposition of a civil financial penalty.

This will become even more relevant to CCGs in the foreseeable future as the regulations are being amended and will bring health and social care within the purview of the rules.
